Support for municipalities wishing to open Winter Emergency Hubs:

<u>Potential facilities</u>: Please note that buildings may need to be activated with limited notice (for example, less than 48 hours). Sites should be in good condition, have restrooms, and at least 3,000 sq ft of space. The Department of Housing is available to provide guidance and support in identifying potential sites. Sites that accommodate approximately 20 to 100 individuals (depending on geography and need) would be preferred. Please note, these are general guidelines and not requirements. The Department is open to all options. Facility examples include recreational and/or community centers, senior centers, VFW Halls, and religious facilities (e.g., churches, synagogues, mosques, etc.) offered on a non-sectarian basis. <u>Identifying partners and potential provider support</u>: Existing service agencies may be able to provide capacity, guidance, support services, and/or other logistical support. Municipality must coordinate with provider on the specific services the provider is able to offer. <u>Anticipated weather triggers:</u> Additional information regarding precise weather triggers and the process for opening the emergency hubs will be provided in the grant agreements for selected awards. It is anticipated that the triggers will be based on public health/emergency criteria and/or National Weather Service forecasts that include sustained multi-day single digit or below zero temperatures or wind chill. Although it is not known the precise number of days the emergency hubs would be opened, we share the following information for planning purposes: there were up to 10 days per year with single-digit temperatures (on the basis of temperature alone, before factoring in wind chill or other winter storms) in the past 3 years. For budgeting purposes, we request that you plan for opening the emergency hubs for 10 days and request that you also provide a per-day rate for opening the hubs on additional days should that be necessary.

<u>Can non-profit partners serve as the applicant?</u> Although this funding is dedicated for municipalities, non-profit partners (e.g., homeless service providers) interested in opening shelters and/or warming centers are encouraged to seek funds through the Consolidated Homelessness Fund process.
